

## EXHIBITION GUIDELINES (CONTINUED)

### Rules:

Original, two-dimensional paintings and drawings may be submitted that meet exhibition guidelines. (Prints, reproductions, computer art and photographs will not be accepted.) Each exhibitor may submit one or two works meeting the following criteria:

- No one entry may be larger than 30 x 37 inches (including frame).
- No one entry may weigh more than 35 pounds.
- Each entry must be framed and/or folded canvas edges, and wired for hanging. CLIPS ARE NOT ACCEPTABLE.
- Entries not properly prepared or presenting difficult handling or installation problems will not be accepted.
- No art work may be submitted a second time
- Entries must be picked up at the close of the exhibition on Mon., March 8 between 8:30 a.m. & 5:00 p.m. Des Moines Women's Club is not responsible for works not picked up at the close of the exhibition.

### Entry Data:

There is no fee to enter. No pre-registration is required. Please submit three (3) copies of the entry form (available in this brochure) for each entry. The Art Exhibition Committee shall act as a selection committee accepting entries which have fulfilled the requirements of the show.

### Awards:

Awards shall be made to outstanding works of art in each category - Professional & Nonprofessional: First Prize of \$125, Second Prize of \$100 and Honorable Mention Certificates in both categories.

### Sales:

Any painting sold during the exhibit will be assessed a fee of 25% of the purchase price by the Des Moines Women's Club.

### Insurance:

The Des Moines Women's Club assumes no responsibility for the entries. Every reasonable care will be taken in handling all works submitted, but artists desiring to insure their work must make their own arrangements. Submission of an entry to this exhibition will be understood to indicate agreement on the part of the artist with all conditions set forth in this brochure.

**Eligibility:**

This exhibition is open to artists in Central Iowa. The show will be classified and hung in two groups: Professional and Nonprofessional.

**The Professional Artist:**

- Artists who make a living through major art commissions and sales of their own original art work for \$300 or more, or
- Artists who are participating members of a professional artists' organization, or
- Artists who have had their original art works accepted in two (2) or more juried exhibitions. (These exhibitions could include the Iowa Artists Annual Show, Des Moines Art Festival, Iowa Exhibit at Heritage Gallery, Iowa State Fair, etc.), or
- Artists teaching classes in studio art.

**The Nonprofessional Artist:**

Artists who do not qualify under the above Professional Artist requisites. Exhibiting works at a local bank, store, or Women's Club does not qualify an artist as a professional.
